10th Resolution

Today on April 2021 a Joint Gram Sabha (DehMajlis) of village
PanchayatsDarnambal, Tarzoo A, Tarzoo B, Tarzoo C and Rakh e Hiagam was held
at Darnambal Block Sopore district Baramulla.

Sarpanches, Panches of all the four panchayats participated in the meeting along with large number of adults of these villages. In addition to it the members of local Forest Rights Committee and Central Auquaf Committee Tarzoo were also present in the meeting.

The issue related to garbage dumping by Municipal Council Sopore was the main agenda of the meeting. It was unanimously resolved as under:

- The municipal solid waste dumped in the area is violating the Municipal Solid Waste Rules and Wetland Conservation Rules 2017
- 2. The land on which Municipal Waste is being dumped is a Forest Land on which local population has certain rights under the Forest Rights Act which is also known as Community Forest Right (CFR), the community holding Forest Rights have certain duties as per section 5 of Forest Rights Act 2006. The relevant section reads as:

"Duties of holders of forest rights. - The holders of any forest right, Gram Sabha and village level institutions in areas where there are holders of any forest right under this Act are empowered to-

(a) protect the wildlife, forest and biodiversity;

(b) ensure that adjoining catchments area, water sources and other ecological sensitive areas are adequately protected;

(c) ensure that the habitat of forest dwelling Scheduled Tribes and other traditional forest dwellers is preserved from any form of destructive practices affecting their cultural and natural heritage;

(d) ensure that the decisions taken in the Gram Sabha to regulate access to community forest resources and stop any activity which adversely affects the wild animals, forest and the biodiversity are complied with.

As section 5 (a) (b) (c) (d) of FRA 2006 empowers Gram Sabha to protect and preserve wildlife, forest and biodiversity of our villages Darnambal, Tarzoo A, B and C and RakheHaigam we resolve that Municipal Council Sopore should stop dumping Municipal Solid Waste in Darnambal area.
